

## Privacy Policy and Statement

All personal information collected on this web site will be maintained in accordance with the Husk Industries Pty Ltd Trading as Husk Distillers ("Husk Distillers") Privacy Policy. This Policy has been drafted having regard to our obligations under the Privacy Act 1988 (including the National Privacy Principles) ('**Privacy Act**').

Husk Distillers will collect Personal Information about you at various times including when you register or subscribe on-line for goods or services we have on offer or if you enter a competition or complete a survey or forward any comments to Husk Distillers.

Husk Distillers, is committed to ensuring that the collection, retention, use and disclosure of the Personal Information you provide (i.e. information which is collected and identifiable as relating to you personally) complies with all applicable legal requirements and that there is no act or practice that interferes with your privacy rights. All possible steps are taken to ensure that any Personal Information you provide online through [inkgin.com](http://inkgin.com), [huskdistillers.com](http://huskdistillers.com), or [huskrum.com](http://huskrum.com) is not disclosed to or accessed by unauthorised persons and is used only for the purpose for which you have provided it.

#### **Why we collect Personal Information?**

We collect Personal Information for a variety of reasons including, in particular, to enable us to process and deliver purchase orders, to improve the nature of the goods and services we provide and to more accurately market our goods and services and research our customers. From time to time we will send details of promotions and special offers to you by email. However, you can 'opt out' from receiving any further marketing or promotional material from us.

We also collect and use Personal Information for **secondary** purposes including:

- (i) to provide targeted and behavioural advertising and

We will not collect Personal Information secretly or in an underhanded way.

If You do not provide Your Personal Information to us, We will not be able to customise inkgin.com, huskdistillers.com, and / or huskrum.com for You and provide information and content most likely to be of interest to You

**Who do we give your Personal Information to?**

We will only use the Personal Information you provide to us through inkgin.com, huskdistillers.com, or huskrum.com for the purpose for which it was provided and directly related purposes and in the normal business operation and marketing of the goods and services offered on inkgin.com, huskdistillers.com, or huskrum.com.

Husk Distillers may disclose personal information about you in some circumstances. Husk Distillers may disclose your personal information to third party contractors and service providers who help us to operate this website and provide a service to you. Husk Distillers may also share your personal information with it's related bodies corporate (as defined in the Corporations Act 2001 Cth) to help us ensure that your personal information remains up to date and complete and so that we may better understand and meet your needs and interests. We will not give your Personal Information to any other third parties without your prior consent. The only exceptions to this are;

a) when we are required to disclose the information by law or to protect our rights, safety or property. When we have to send your Personal Information to contractors or service providers to carry out work on our behalf, or to related bodies corporate, we require these organisations to comply with this privacy policy and, in certain situations, require a confidential undertaking to protect your personal information. We will not permit others to use your information beyond what is necessary to assist us and wherever possible they will be required to provide a confidentiality undertaking to protect your Personal Information; and

b) We may use or disclose Personal Information in order to avoid an imminent threat to a person's life or to public safety. We may also use or disclose Personal Information in order to assist law enforcement or conduct internal investigations into actual or suspected unlawful activities.

We may communicate with you electronically about matters associated with your use of inkgin.com, huskdistillers.com, or huskrum.com (which may include, but will not be limited to, administrative matters, technical issues and requests to do online surveys). Messages may include marketing. You consent to receiving such messages.

We may use cookies and similar technology ('**Cookies**'), to collect information about You and how You use inkgin.com, huskdistillers.com, or huskrum.com. You may use Your browser to disable Cookies but this may impact Your ability to use inkgin.com, huskdistillers.com, or huskrum.com. We will not, without Your consent, attempt to

match de-identified or anonymous data collected through surveys or Cookies with information identifying an individual. Cookies may reside in places that include Your computer, on inkgin.com, huskdistillers.com, or huskrum.com or in emails that We send to you.

You have the ability to accept or decline cookies. Most Web browsers automatically accept cookies, but you can usually modify your browser setting to decline cookies if you prefer.
